Subject: OH candidates of CGLE-2020 examination seeking exemption from appearing in DEST

As per Para No. 12.12.1.4 of Recruitment Notice CGLE-2020, "OH candidates opting for the post of Tax Assistant in CBDT are exempted from appearing in Skill Test, provided such candidates submit a Certificate in the prescribed format (**Annexure-XIV**) to the Commission from the competent Medical Authority, i.e., the Civil Surgeon of a Government Health Care Institution declaring him/ her to be permanently unfit for the Typing Test because of a physical disability.

- 2. Exemption is allowed only for DEST. (For the post of Tax Assistant in CBDT only, Not for any other post in this Recruitment)
- 3. The OH candidates qualified from Karnataka Kerala Region seeking exemption for DEST may, in their own interest, send a request along with scanned copies of following documents on email ID: adexam.kkr.ssc@gov.in, *latest by 29.07.2022*.
 - (i) **Medical Certificate** seeking exemption in prescribed format (**Annexure XIV** of the notice of Examination) from the competent Medical Authority, i.e., the Civil Surgeon of a Government Health Care Institution, **with all columns duly filled in**.
 - (ii) **Undertaking** as per the format annexed to this notice (Copy enclosed).
- 4. The decision of the competent authority on grant of exemption will be conveyed to the candidate on or before the day of Skill Test.
- 5. The candidates are required to produce all these documents **in original** before the Commission, if they are called for document verification.
- 6. PLEASE NOTE:
 - (i) OH candidates opting for post of Tax Assistant in CBEC are not exempted from DEST.
 - (ii) HH and VH candidates are not eligible for exemption from the Skill Test.
 - (iii) No exemption from CPT is allowed for any category of PwD candidates.
