

- Quotations should be submitted in a sealed cover, super scribbling "Quotations for clearing Old Unwanted Chairs and Records". Firms should ensure that quotation is submitted with EMD of ₹500/- (Rupees Five Hundred Only) in the form of DD/Cheque drawn in favour of Regional Director, Staff Selection Commission (KKR), Bengaluru. Cash will not be accepted under any circumstance. Quotations without EMD will be summarily rejected.
